Thane Rosenbaum is the author of the novels, *The Golems of Gotham*, *Second Hand Smoke*, *Elijah Visible* and *The Myth of Moral Justice: Why Our Legal System Fails to Do What's Right*, which was selected by the *San Francisco Chronicle* as one of the Best Books of 2004. His most recent book is an anthology entitled *Law Lit: From Atticus Finch to The Practice: A Collection of Great Writing About the Law*. Rosenbaum's articles, reviews and essays appear frequently in *The New York Times*, *Los Angeles Times*, *Wall Street Journal*, *The Washington Post*, and *The New York Sun*, among other national publications. He appears frequently at the 92nd Street Y where he moderates an annual series of discussions on Jewish culture and politics. Rosenbaum is the John Whelan Distinguished Lecturer in Law at Fordham Law School, where he teaches courses in human rights, legal humanities, and law and literature, and also directs the Forum on Law, Culture & Society.
