Since the entry of the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005, additional new rights and responsibilities have been placed upon debtors, creditors and their attorneys. Decisions pertaining to when, where and whether to file an individual bankruptcy case have been significantly modified. With each change there are added strict new duties.

The program will include:

- A panel discussion by United States Bankruptcy Judges from the Southern District of Florida;
- A presentation by the Standing Chapter 13 Trustees from the Southern District of Florida on the new obligations of Chapter 13 debtors;
- A panel discussion by Chapter 7 Panel Trustees and counsel for the Assistant United States Trustee for the Southern District of Florida on whether a debtor's bankruptcy has been filed in bad faith;
- A presentation by the Clerk of Court for the Southern District of Florida regarding new mandatory requirements of electronic filing of court pleadings and other documents;
- An attorney's ethical and mandatory duties before, during and after a bankruptcy case has been filed.
