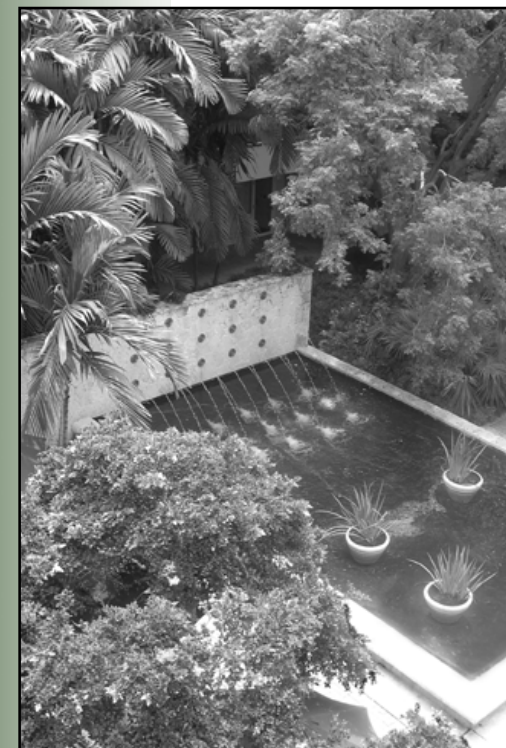

The Dean’s Circle

Among the University of Miami School of Law’s 15,500 alumni are some of the nation’s most successful attorneys. Appreciative of the Law School’s contribution to their success, some of these alumni are committed to helping UM Law continue its growth as a premier educator of tomorrow’s leaders. They—along with other friends of the Law School—are members of an elite group of donors known as the Dean’s Circle.

By making annual gifts of \$1,000 or more to the Law Annual Fund, scholarships, or other UM Law programs, Dean’s Circle members form a partnership with alumni, parents, and friends to advance the mission of the Law School.

Joining the Dean’s Circle

An annual gift of \$1,000 or more to the Law Annual Fund, to a scholarship or to any programmatic activity of the Law School entitles you membership in the Dean’s Circle.

Dean’s Circle membership also entitles you to recognition as a member of the University of Miami President’s Circle at the following levels:

- Platinum (\$10,000 and up, annually)
- Gold (\$5,000 to \$9,999)
- Silver (\$2,500 to \$4,999)
- Bronze (\$1,000 to \$2,499)
- Protege (\$500 to \$999 for alumni who graduated within the past 10 years)
